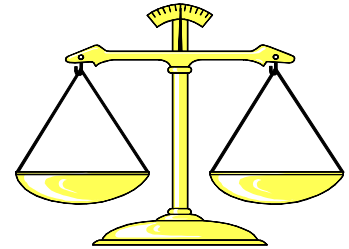

MAY 2012 GRADUATES:

Deadline is quickly approaching for filing your Statement of Candidacy for Degree. Deadline is Friday, February 17, 2012. Please see Julie in Office of Budget & Records (SP276) to pick up your Statement of Candidacy for Degree form. You will then need to fill it out and return it to Julie, along with \$75 check (made out to NIU) by the deadline. **This form MUST be completed, and \$75 paid in order to graduate (regardless of whether you plan to participate in graduation ceremony or not).**

The standard policy at NIU COL is that a Dean's Certificate is prepared for all graduates by the Office of Budget & Records (SP276) and sent to IBABY. They (Christina and Julie) will do this in May after verifying that you have fulfilled all requirements for graduation. However, if you are applying to take the bar exam in a state other than Illinois and that state requires a form similar to the Dean's Certificate then you will need to provide a copy of that form to the Office of Budget & Records.

ADMISSIONS AND FINANCIAL AID

1Ls and 2Ls FAFSA Reminder:

It's that time of year again... if you plan on obtaining federal student loans for the 2012-2013 academic year, a FAFSA application should be completed by the University priority deadline of March 1, 2012. Remember that when you fill out the FAFSA all law students are considered independent and you do not need your parent's tax information. **We encourage all of you to complete your income tax forms so that you may complete your online FAFSA application prior to March 1.** You may access the online form at fafsa.ed.gov.

Would you like free help applying for FAFSA? The Student Financial Aid Office is holding FAFSA Completion Workshop which will be taking place every Friday from 10am to 2pm starting February 18th through May 6th in 245 Swen Parson Hall. There will be a kick-off event called **FAFSA Fun Fest on Friday, February 18th** which will include food, fun, and donated prizes to encourage students to file the FAFSA early

BRIDGE TO THE BAR SCHOLARSHIPS:

The initial Kenneth and Ellen Chessick "Bridge to the Bar Scholarships" will be awarded this Spring to five third-year students, to help these deserving students offset their expenses while they take the bar this summer. Each scholarship is \$5000. Details on the application process are forthcoming, and will be e-mailed to all third-year students who are scheduled to graduate in May 2012.

Bar Study Loans:

3Ls it is time to think about your bar study loans. The bar loan is a private loan, and a credit check will be performed. The loan helps finance bar exam costs, such as bar review course fees, bar exam deposits and fees, as well as living expenses. You may borrow bar study loans from a minimum of \$1,000 to a maximum of \$15,000. You may apply for a Bar Study Loan through your current student loan lender, or you may use a completely different lender from your undergraduate loan lender. If you have not borrowed the maximum on your Federal Stafford Loans, you may want to use the balance to fund your bar exam preparation. Start your research on the bar

loans early so that you get the best interest rate possible since the bar loan cannot be consolidated with your current Stafford Loans. **All bar loan applications must receive a school certification signed by the University Student Financial Aid Office, 2nd floor of Swen Parson Hall.** The following are some of the private lenders that are still providing bar loans. *Research any additional lenders and compare their interest rates before you sign.*
